What this report means:

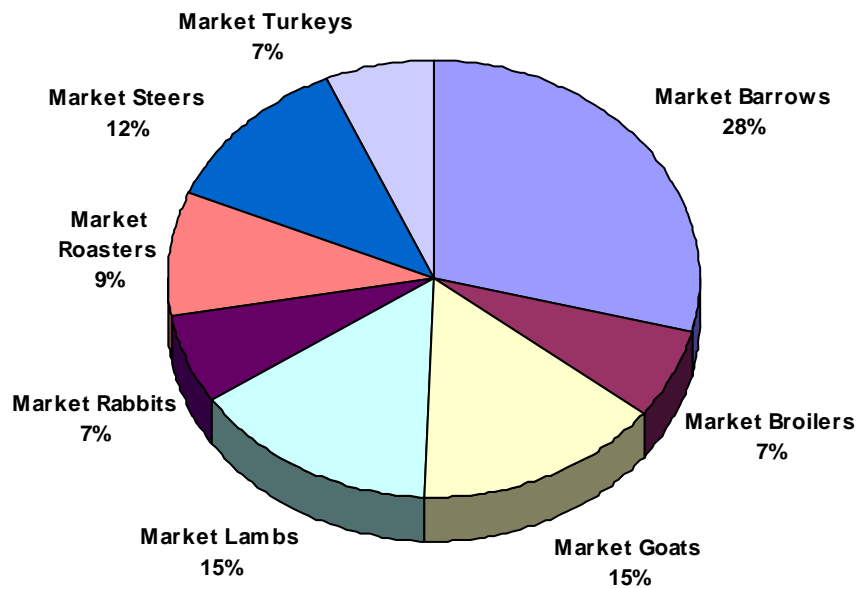
